READY Nonprofits Overview





Goals/Objectives of the Training Program (Phase I)

The *READY Nonprofits* Training Program has three objectives:

- Train Appalachian nonprofit organization executives, as well as their staffs and board members, to develop greater organizational capacity and become more sustainable, enabling them to better serve their communities.
- 2. Address the challenges faced by economically distressed communities by prioritizing **economic development-related** organizations.
- 3. Support **low-capacity nonprofit** organizations in remote areas of Appalachia to improve their skills related to nonprofit and grant management.



READY Nonprofits Training Program Learning Outcomes

- **Strengthen** operations, programming and fundraising specific to nonprofit organizations.
- Build a network of nonprofit colleagues across Appalachia.
- **Develop actionable plans** to address organizational capacity challenges.
- Help nonprofits better serve their communities through highquality skill development designed to improve organizational capacity
- Sustain the work of participating nonprofits over time.
- Leverage resources to improve the quality of life and foster economic development within their communities.





Eligible Applicant Organizations

This program is open to **nonprofits serving Appalachia.**

The following entities are eligible to apply (both criteria must be met):

- Public or private nonprofit organizations or associations, including labor unions; and
- Entities that serve communities in Appalachia

Up to 75 nonprofits will be selected to participate.



Eligible Applicant Organizations

Nonprofit organizations who meet any of the following criteria are **encouraged to apply**:

Entities That Are NOT Eligible

- For-profit organizations
- Individuals applying on their own
- Institutions of higher education or major hospital systems
- Organizations that **do not serve** communities in the Appalachian Region, as defined by the Appalachian Regional Development Act (ARDA), 40 USC 14102(a)(1).

- Organizations that meet the criteria for READY Appalachia's other three learning tracks: local development districts (LDDs), local governments, and community foundations

Eligible Participants Two participants from each nonprofit organization

The **Primary Participant** must be the:

executive director, or equivalent

The **Secondary Participant** is selected at the discretion of the organization dependent on the goals of participating in the training program and can be:

A staff, board, or committee member, or another relevant individual



Structure of the Training Program

The 7-week virtual training program will be conducted via Zoom

- Cohort learning
- Sessions facilitated by experienced instructors and subject matter experts

Each course will consist of the following:

- Five cohort-based **virtual** training sessions, 1.5 2 hours each session
- One hour of **assignments** each week, outside of course time
- Two one-hour, **one-to-one consultations** with the instructor as part of the seven-week course
- Two one-hour **follow-up consultations** occurring three months following the completion of the seven-week course

All courses will include a **pre- and post- course survey,** as well as a **post-course** evaluation.

Course Schedule





- The READY Nonprofits training program will be offered June 23, 2025, through September 23, 2025, with exact dates and times to be determined based on participant and instructor availability and courses selected by applicants.
- The total **time commitment** for the training • program (to include assignments outside of course time) is estimated to be **20 hours**.

Course Curriculum


- Entities will participate in <u>one</u> of the eight courses.
- Applicants will prioritize their top two courses as part of the application process.





Cohort Design

Participants selected for the **READY Nonprofits Training Program** will be organized into **15** cohorts, with up to **five** organizations per cohort. The two participants from each organization will participate in the same cohort and course.





Course Option 1: Board Development

Course Overview:

The course is designed to **equip** individuals with the knowledge and skills needed to cultivate **effective and high-performing** nonprofit boards. Participants will explore fundamental principles of governance, ethical responsibilities, recruitment, onboarding, and the roles and responsibilities of board members. Emphasis will be placed on fostering a **culture of accountability** and navigating the unique challenges faced by nonprofit boards.





Course Option 2: Financial Management

Course Overview:

The course will equip participants with the essential skills and knowledge necessary to **effectively navigate** the unique financial landscape of nonprofit organizations. Participants will gain a comprehensive understanding of **financial reports** and how to **facilitate discussions** and **presentations** to the board, funders, and stakeholders. Participants will engage in hands-on exercises, practical templates, and discussions that allow for application within their organization.





Course Option 3: Fundraising

Course Overview:

The course offers an exploration of **strategies** and **techniques** to create a **sustainable path** to consistent, **diverse fundraising**. Participants will delve into the art of **donor relations**, cultivating long-term relationships and leveraging technology to **amplify fundraising** efforts.





Course Option 4: Marketing/Communications

Course Overview:

The course is designed to equip participants with essential skills and strategies to effectively **promote their missions** and **engage with diverse stakeholders**—both internal and external. The course will focus on practical aspects of planning and implementing **marketing**, **fundraising**, and **crisis communication plans**. Participants will learn to tailor communication strategies to different audiences using storytelling, social media, and visual content to **enhance engagement** and build meaningful connections with donors, volunteers, and the community.



Course Option 5: Programs/Operations

Course Overview:

The course offers a strategic **exploration** of the essential skills and principles necessary to **effectively plan, implement**, and **optimize programs** within mission, vision, and value-driven organizations. It will also focus on strategic **program development** and **scaling**, emphasizing the integration of data-driven decision-making and the use of technology to enhance efficiency. Participants will explore techniques for assessing **program impact, measuring outcomes**, and adapting strategies based on **evolving needs** and community dynamics.





Course Option 6: Human Capital (Human Resources)

Course Overview:

The course will explore the unique **challenges** and **opportunities** in **managing personnel** within the context of mission-driven organizations. Participants will delve into the fundamental principles of human resource management, covering key topics such as recruitment, onboarding, employee relations, **performance management**, **succession planning**, and **legal compliance** specific to the nonprofit sector.





Course Option 7: Grant Writing and Management

Course Overview:

The course is designed to empower participants with the skills and knowledge needed to **secure** and **effectively manage federal grants** for their organizations. Participants will review the intricacies of federal grant writing, covering key components such as **needs assessment**, **project design, budget development, key performance indicators** (KPIs), and **proposal submission**. Participants will gain hands-on experience in crafting grant applications that align with their nonprofit's mission, fostering the essential skills needed to successfully navigate the competitive federal grant landscape. The course reviews federal grant management, addressing critical aspects of post-award activities.





Course Option 8: Strategic Planning

Course Overview:

This course is designed to provide participants with a thorough understanding of the principles and practices of strategic planning. Participants will learn how to conduct an **environmental scan** to assess internal and external factors affecting an organization, **set strategic goals**, and **develop action plans** for successful implementation.





Requirements for Participation

Participants who commit fully will get the most out of the program.

To be **eligible for the grant opportunity**, <u>both</u> participants <u>must attend</u> at least:

- 4 of the 5 virtual sessions
- All (2) of the one-to-one consultations
- All (2) of the follow-up consultations

ARC expects the two participants identified in the application will be the participants representing the nonprofit organization throughout the duration of the program.

- Participants should **complete all assignments** before sessions each week.
- Failure to fully participate **could disqualify nonprofits** for Phase II (Grant Opportunity).

Grant Opportunity (Phase II)

Participating nonprofits who successfully complete the training program will be eligible to **apply for up to \$25,000** in ARC funding, with no match required, to implement internal capacity-building projects.

- Projects can focus on a capacity need identified during the training component
- Note: construction projects will not be allowed




